- Item 1 PR package for Schools and Universities
 - There was some discussion on the letter we got input from several addicts and then the PI chair would use best judgement in the letters. The Area voted to spend \$160 and move forward with sending the packets to high schools, colleges, and universities in our geographical area. We need to start preparing in case the facilities need more or want presentations.
- Item 2 Meeting List
 - o 1,000 meeting list were printed and are available for group to use.
- Item 3 Kickball Event Update
 - o There are three areas involved, Miracle Area, Fellowship for Freedom, and Never Alone Never again. The event will be held in Lawrence this year. Miracle Area would like to see this be an annual event and next year hopes that Topeka will host the meeting. The event will have BBQ, 2 speakers (1 from Lawrence (Female) and 1 from Topeks (male John B). There will be Pie in the Face which each area offering up some of their trusted servants. The goal of the pie in the face is to help Miracle area cover the cost. The shirt design has been completed and there are three colors this year... Green (FFFA), Blue (Miracle Area) and Black (Never Alone Never Again). We will get 25 shirts (3 S, 5M, 5L, 5 XL, 3 2XL, 3 3XL, 1 4XL) for \$140. We are then able to sell the shirts at whatever cost we want, the money we raise will be kept by our Area. The shirt cost was paid for. Any additional funds raised will be given to area.

NEW BUSINESS/OPEN FORUM

- Item 6 Create a Literature Chair Position
 - Our acting RCM would like to see us create a literature chair position that would allow our area to make literature available to our area committees and our groups without waiting long periods of time. There was some discussion about continuing to use Miracle Area and the Wisconsin Service Center. It was also discussed that John "Miracle Area's Literature Chair" has expressed a willingness to help teach us how to begin and smoothly run Literature Committee. The motion was tabled to go back to groups to ask if they would like to see this position and if so if they are willing to commit to using it.
- Item 7 Event is raise money for PI/PR and to support struggling groups
 - o The H&I Chair made a suggestion that our area might want to have a function to raise money so that the area can support its struggling groups and continue our PI/PR efforts to reach young addicts in high school, colleges, and universities. The GSR for 21st Street Recovery offered to chair a new Activities Adhoc Committee and was approved. Several members expressed willingness to be on the committee. We decided to do a field day type event, a member from Dirty Little Secret suggestion getting a dunk tank. A member suggested that we use the same facility as the H&I event. The area agreed to the dunk tank and venue. The original date was Sep 2, but was moved to Sep 9th due to scheduling conflicts. The area agreed to provide \$300 for this function.
